Dear Mr Cruse-Taylor,

49,000 children and young people in the UK are living with life-threatening health conditions. With the outbreak of COVID-19, the number of people needing hospice care has risen over recent weeks and Hospice nurses and front line clinical staff now, are putting their lives at risk caring for vulnerable patients.

The children and young people we care for at Hope House need us more than ever during this difficult and uncertain time. It is vital that we stay open to offer end-of-life care and care after death for them and their families.

We are working closely with the NHS; freeing up beds on children's wards by transferring children with life-threatening illness from hospital to our hospices, where they will be cared for by our experienced palliative care nurses.

Our community nurses, neonatal nurses and social workers are supporting families in crisis due to the pandemic – with a hospice team allocated to each family to ensure sure that they can access all available support, from us and others in the community.

However, our ability to raise vital funds has been severely affected by the COVID-19 crisis. Just 14% of our annual income comes from statutory sources, including the NHS. 68% is usually raised through fundraising activity and a further 9% through our shops. With shops now closed and our events cancelled, we are experiencing a sudden and severe drop in income and we know that at least £1 million in fundraising income will be lost to us.

In addition, our recovery will be slow and difficult as things gradually return to normal, with many individuals and businesses who have long been our supporters financially impacted for some time, affecting their ability to donate to us. That's why your support is so crucial.

We are writing to ask you to help us provide vital nursing care at this time for 40 children and families living in the Telford area, including those in your local community. This is where our need is greatest, and where your financial contribution would have the biggest impact. A donation of £250 would pay for one of our specialist palliative care nurses to provide a day of expert care for one of these terminally ill children at the hospice or in their own home.

Any cheques should be made payable to 'Hope House Children's Hospices'. If you require us to complete a grant application form, we have enclosed an SAE for this to be returned to us.

Thank you so much for considering donating to us. With your help we will continue providing care for the most vulnerable for the duration of this crisis and for many years to come.

Hello lan,

Thank you for our phone conversation today.

I would be most grateful if you could issue this update on Telford Carers Centre supporting unpaid family carers of all ages.

The Carers Centre Team (and all of Telford and Wrekin CVS) are now working remotely from home – it's been a bit of a strange transition – but we're settling into a different mode of working.

I think it's fair to say the whole team have taken on the task of supporting our carers at this difficult time with enthusiasm and a newly found urgency — we've tried to make sure that although we can't give that personal face-to-face and cosy group support currently, we can use technology to provide something quite similar.

- Our frontline team are dealing with dozens more calls a day people are understandably more anxious and for carers the situation can go from quite difficult to sometimes critical.
- We are currently contacting our most vulnerable family carers with a 'Safe and Well' Phone call session. We can then check how they are and see how we can support.
- We're also holding online 'Virtual Youth Clubs' and Wellbeing Groups for all ages.

I'm writing to ask whether Chetwynd and Woodcote Parish Council, would consider giving a donation

- we are working at more than full capacity to ensure that carers get the support they need and any amount would be so much appreciated to help us through this time.
